



Chairman's Report

Year ending 31 July 2023

The past year has seen us complete our third year of trading with both the Grassroots collaboration agreement and the full outsource of all operations to Maxserv. The relationships with both organisations remain strong and continue to deliver positive growth in venue numbers and performance.

Performance in the South Island has been steady with many new grant applicants discovering the Grassroots avenue of funding. The benefit of those venues has given rise to a future operating model with the venues of the Bendigo Trust. Bendigo has elected to cease operations and move its remaining venues to Grassroots. That transition is taking place early in the next financial year and will cement a solid base of venues in the lower South. It was always envisaged that the collaboration with Grassroots would open the doors to this type of opportunity so it is pleasing to see the first small Trust see the value and make the leap. It has highlighted the lead time required and flexibility in structure to achieve a deal that is welcomed by both sides. We remain optimistic that other Trusts may follow in the future.

There is an increasing trend for territorial local authorities to seek to implement more restrictive gaming policies. Although gaming is already heavily regulated and monitored, councils continue to try and impose their own moral views into policies, yet at the same time benefit directly and indirectly from many organisations who apply for funding for use of council facilities and holding of community events. There is no simple answer to this other than to continue to represent the views of the sector at each review hearing.

Our performance through the year was stable and resulted in meeting the year-end financial objectives and statutory requirements for class 4 societies. This was our first full year post covid restrictions so a better indication of future trading results. Much work and planning was done to ensure we met the year end targets and Maxserv provided excellent forecasts and guidance on our performance to ensure we could achieve this.

During the year we have continued to distribute approximately 90% of grant funds to the communities where the funds were raised from and have seen a good volume of new grant applicants particularly in areas where we have a new venue.

We remain focussed on distributing a majority of grants for sports and getting funding as close as we can to the ultimate participants. Now that there is more certainty for the holding of events we are seeing a return to pre covid levels of applications for major events.

For the year ahead we remain optimistic for both grant distributions and a trading surplus, while remaining mindful of the need for investment in EGMs and room upgrades to ensure we maintain an attractive and compliant gaming offering to the various communities we operate in. Securing new venues is also important, tempered only by financial consideration of funding and ability to service borrowings in a high inflation economic environment.

Finally, a thank you to all the Maxserv team, our venue operators, our suppliers, and our directors who have contributed to the past year. Your continued support is recognised and appreciated, and we look forward to another positive year ahead.

For every dollar put in to a gaming machine, 91 cents on average is returned to the player in winnings. This is the highest rate of return of any form of legal gambling in New Zealand.

At least 40% of revenue generated from gaming machines and not returned to the player goes towards community initiatives in the form of grants. Every year, pub and club gaming machines return around \$300 million to the community through applications from around 13,000 groups.

The Government receives around 40% in taxes, duties and fees, and the rest goes towards administration and venue costs, and the mitigation of problem gambling.

Around \$11 million of gaming machine revenue goes to the Ministry of Health annually through the problem gambling levy for implementing their harm minimisation programme.

Authorised purpose

Grassroots Trust Central Limited is licensed to operate gaming machines to raise money for the following authorised purposes:

- Any amateur sports teams or clubs which are open to the general public and which are affiliated to a recognised or national body and which complete in recognised leagues.
- **B** The promoting, controlling or conducting of race meetings under the Racing Act 2020 including the payment of stakes.
- C Any charitable, philanthropic or cultural purpose or any purpose that is beneficial to the community or a section of it.

All authorised purposes include, but is not limited to applications for the promotion and development of:

- Amateur sport which meets the criteria, including the provision and maintenance of facilities, equipment, uniforms, services, playing and training costs
- Community organisations which are established for charitable, educational or cultural purposes beneficial to the community or a section of it

With the exception of grants to national societies or agencies, funds are mainly distributed within the local community in which they are raised.

No payment, commission, or any other kind of reward, financial or otherwise, can be attached or demanded as a precondition for the payment of a grant.

Authorised purposes must benefit the community and not result in commercial or personal gain.

Spirit of Adventure Trust Board

The Spirit of Adventure Trust Board is a Charitable Trust transforming the lives of young people for nearly 50 years. The Trust was set up to empower young kiwis to reach their full potential through the challenge of the sea. Over 1,200 14 - 18-year old's head out on youth development voyages each year where they can take part in this unique rewarding experience. Waikanae Surf Lifesaving Club Incorporated

Waikanae Surf Lifesaving Club Incorporated have been patrolling the beaches in Gisborne for over 70 years. They provide a volunteer lifeguarding service to the Gisborne community and visitors by patrolling the Waikanae Beach. Their core purpose is in the community health, education, and the sport sector.

Grassroots Trust Central have provided grants to the value of \$105,265.00 towards various salary costs, accommodation costs and purchasing vital rescue equipment in the way of paddle boards and surf skis.

Clara Wilson, Club Manager said "The grant we received for help with the coaching salaries had a huge impact on what we were able to offer last season. It meant we were able to continue delivering our program, both in the pool and in the ocean, to develop stronger, fitter, faster lifeguards. We were proud to be able to schedule 90 qualified quards onto volunteer patrol teams over the summer months to keep the community safe in and around the ocean and rivers. We also had 5 of our members join the summer regional patrol team. Over 1,500 patrol hours were logged by our guards and preventative actions by our teams had a positive effect on over 2,500 members of the public. The summer holiday program was a roaring success where the program is aimed at 7 - 14-year-olds and teaches ocean safety and confidence in a safe and educational setting a very pleasing outcome! Wellington Zoo Trust
